kin may demand the death sentence, but they are encouraged to pardon the murderer and be compensated for their loss.

This principle easily extends to lesser offenses. When someone is found to have committed a crime, locking him away will only turn him into an unproductive and alienated person. It will also put him in an environment that perpetuates his or her criminal habits. Instead society should enforce a system where the criminal has to compensate the victim by working to "pay them back." In this way the victim is helped. the innocent families of both victim and criminal are saved from terrible emotional and economic deprivation.

Recently, a few judges have begun to use some innovative sentencing. One such example is Judge Joe Brown of Memphis, Tennessee. Judge Brown has used the principle of compensation by allowing victims, accompanied by deputies, to go into the burglar's home and take what they want, up to a limit close to what was stolen from them. The results have helped the victims get beyond their anger, and have given the burglars a sense of the loss they inflicted - and has kept them out of

By God's leave, he entered the prison as a servant, and left it as the king's advisor. A Quranic justice system is better for everyone: those who have committed a crime, their victims, the families of both sides, all of society. Quranic Justice

One of the most difficult problems facing our modern society is how we should enforce justice. When a person is found guilty by a panel of his peers, what then?

Now, of course, the most likely result is imprisonment, especially for those coming from less privileged backgrounds.

What does that really mean? Let us stop and think about it. The cost of keeping the average prisoner behind bars is often much more than many of those same people would have had to live on if they were not imprisoned.

- But there is a much greater cost. That is the cost to the families who are deprived of what is often the major or only source of provision for them.
- Not only that, the victims of the crime remain without compensation, and if the crime involved the death of a primary provider, they are irreversibly deprived of that source of income as well.

Of course this deals only with the economic issues, and leaves aside the even greater expense to the happiness and emotional well being of everyone involved.

In recent years, the terrible overcrowding of the nation's prisons has become almost overwhelming. A vast amount of capital is set aside annually to build more facilities which will continue to be essentially eco-

mous amounts of money and human energy for little or no rehabilitation among the imprisoned population. In fact, there are good indications that the most likely thing most prisoners will learn is how to become better criminals!

And the families left behind may see little or no way to survive other than welfare or

What is the solution?

Well, since the revelation of the Torah the scriptural law has been equivalence:

Wherever hurt is done, you shall give life for life, eye for eye, tooth for tooth, hand for hand, foot for foot, burn for burn, bruise for bruise, wound for wound. (Exodus 21:23-25)

And we decreed for them in it (the Torah) that: the soul for the soul, the eye for the eye, the nose for the nose, the ear for the ear, the tooth for the tooth, and an equivalent injury for any injury. If one forfeits what is due to him as a charity, it will atone for his sins. Anyone who does not rule in accordance with God's revelations, these are the unjust. (Quran

Thus, one who commits a crime must repay the victim in kind, unless the victim forfeits it as a charity. So, if someone steals something, their punishment is to

nomic black holes - sucking up enor- replace what they stole (and the Quran indicates that their hand should be superficially marked - not cut off, as has been the traditional interpretation!)

> The Quran reiterrates that the punishment is equivalence and compensation:

O you who believe, equivalence is the law decreed for you when dealing with murder - the free for the free, the slave for the slave, the female for the female. If one is pardoned by the victim's kin, an appreciative response is in order, and an equitable compensation shall be paid. This is an alleviation from your Lord and mercy. Anyone who transgresses beyond this incurs a painful retribution.

Equivalence is a life saving law for you, O you who possess intelligence, that you may be righteous. (2:178-179)

Murder is a very serious crime in God's eyes. So serious that He tells us:

...we decreed for the Children of Israel that anyone who murders any person who had not committed murder or horrendous crimes, it shall be as if he murdered all the people. And anyone who spares a life, it shall be as if he spared the lives of all the people... (5:32)

We see in 2:178-9 that even for this most terrible crime of murder, equivalence and compensation are the law. The victim's

The Unique Properties of Water **Accident or Design?**

As familiar as water is to all of us, being one of the most stable as well as most abundant compounds on earth, it is, nonetheless, an "odd" one. In many respects it is one of the "strangest" substances known to science. Almost all its properties - boiling point, melting point, etc. - are "anomalously" higher or lower) than what one might expect based on its molecular mass of 18 amu (atomic mass units). Certainly these unexpected properties of water make it a uniquely useful liquid (at room temperature and 1 atmo-() sphere) and the basis for life. No other liquid can be substituted for water in the role it plays. The following is a summary of some of its unique characteristics.

1. To demonstrate how some properties of water (H2O) are "anomalous," we compare it with other compounds in the series, H2S, H2Se, H2Te, replacing Oxygen by Sulfur, Selenium and Tellurium (all in the same group and chemically close). It is a general trend that within a given series of compounds, boiling points and melting points increase with the increasing atomic weight of elements. Accordingly, if we plot these properties of the four compounds against their atomic weight, we expect them to follow this pattern. They all do except water. For example, being the lightest compound in the group water is expected to have a boiling point close to -75°C (-105°F). This is nowhere close to the actual boiling point of water, which is $+100^{\circ}$ C ($+212^{\circ}$ F). Similarly, water is expected to have a freezing point at about -100°C (-145°F). This is again much different than the actual freezing point of water. If water did have the "expected" boiling and freezing points, the result would be dramatic. (Actually there would not be life, at least of the kind that we're all familiar with).

2. The fact that water in the solid phase (ice) is less dense than the liquid phase (water expands on freezing and ice floats on top) is taken for granted by most of us and may on occasion cause annoyance as it results in cracking water pipes and pools during winter. Yet this virtually unique property of water is essential for marine life.


If ice were denser than water, it would

sink and accumulate at the bottom of the oceans and lakes. Water in oceans and lakes would show radical temperature changes with depth.

As it is, the ice floats at the top, thereby isolating water and marine life below, keeping the temperature from dropping to the freezing point, and maintaining water as a liquid for marine life.

- 3. Water has a higher specific heat (the amount of energy it takes to raise its temperature) than all of the compounds in the above series, and higher than almost all organic compounds. The typically higher values of both specific heat and thermal conductivity allow water to be used as a storage of heat, and to buffer the temperature of its surroundings. Without this property, we would have extremes of temperature each day (people who live in the desert experience that - very hot during the day, cold at night).
- 4. Water also has a very high surface tension, a phenomenon in which the surface acts as though it were a thin, invisible, elastic membrane. It is because of this property that you can place a needle on the surface of water if you do not break the surface.

A consequence of this property is that it



pounds to concentrate near the liquid surface and making some biochemical reactions more rapid.

The high surface tension is responsible for the so called capillary effect - rise of water in capillary tubes. This property is largely responsible for the transport of water, against gravity, within plants.

5. The dielectric constant (measure of charge distribution within a molecule) for water exceeds just about any other liquid thus allowing it to dissolve polar compounds, NaCl (table salt), into their constituent ions, Na⁺ and Cl. We tend to forget that water is, after all, the least expensive and most effective cleaning

This also causes biologically important compounds such as enzymes and nucleic acids to exhibit what is known as the hydrophobic effect. By aligning themselves toward or away from water molecules. enzymes are, in effect, formed into their "active shape." It is established, biochemically, that it is the "shape" of enzymes that enables them to catalyze biochemical reactions in the living cell. The same enzyme, if laid out differently, would become inactive, thereby bringing the life process to a halt.

Are these facts simply an accident, or are they a result of a well thought out design? This question is answered in the Quran: "Everything we created is perfectly measured." (54:49)

Once again, as in countless other examples, life and the evolution of life would not have been possible without the specific design of God. In this case, it is the properties of water molecules which depend almost exclusively on the special hydrogen bonding between oxygen and hydrogen. Any variation from the known water structure would have resulted in vastly different properties for water with no possibility of life.

Do the unbelievers not realize that the heaven and the earth used to be one solid mass that we exploded into existence? And from water we made all living things. Would they believe? (21:30)

And God created every living creature from water... (24:45)

He is the One who created the heavens and the earth in six days-and His (earthly) domain was completely covered with water ... (11:7)
